## PORTLAND PUBLIC SCHOOLS ELEMENTARY SCHOOL ADA STANDARDS

## March 2013

This summary of standards includes the standards previously published on August 21, 1997 by the design team Hampton/Ritson. Revisions and amendments to those standards shown in bold text reflect the 2010 ADA Accessibility Guidelines changes which became legally enforceable by the US Department of Justice on March 15, 2012. The 2010 ADA requirements were incorporated into the Oregon Structural Specialty Code (OSSC) with minor amendments through the adoption of the ICC/ANSI A117.1-2003 effective March 1, 2012. Sections of A117.1 and 2010 ADA are referenced below. The 2010 ADA did not incorporate every DOJ draft children's standard previously included in this listing by Hampton/Ritson, but where
